More reasons why you want to be a part of the network:

Basic Alerts: In exchange for sharing your payment experience you will receive free risk monitoring on those accounts under our Basic Credit Alert program. The alerts include changes in payment behavior, notice of delinquency risk, and bankruptcy filings among others.

Access to PG Credit Network: Ability to view trade from other PG users and trade contributors to obtain or validate trade references, report special conditions, or gain trusted information quickly.
