- The file you send us must include, at minimum: customer name, street address, Aged AR balance information, and past due amounts. Other identifying data, such as account and phone numbers are highly recommended because it allows us to better match your data to your previous submissions and data provided by other sources.
- If you are going to use Excel or CSV, please include unique column headers and place them all in a single row, preferably starting in the first one

Step 2: Send the completed file to <u>data@eprofitguard.com</u>

What happens next

ProfitGuard will review and send back a verification file

Spot check all fields and columns to make sure they are correct and confirm with PG

ProfitGuard will set up a Basic Alert Portfolio with your customer files
